"Our experience with verseas investments has ot been very good, therefoe, we are very careful befoe we step out to overseas," hairman Sajjan Jindal sad on the sidelines of the anual general meeting of SW Steel shareholders, adling, however, that they are looking at opportunities n the US".

Sajjan Jindal, chairman, ISW Steel's interest in US teel-making assets assumes significance as it recently lost in a competitive bid to acquire troubled Italian steel maker Ilva. The Italian steelmaker was acquired by a consortium led by Lakshmi Mittal's Arcelor Mittal.
