New Delhi: Chennai-based Refex Industries and Gensol Engineering of Ahmedabad have called off their deal under which the latter was to sell 2,997 electric vehicles to the former.

In stock exchange filing, Refex Industries cited "evolving commitments at both ends" as the reason for the decision, stating that these challenges would make it difficult to complete the transaction within the originally planned timeline.

"The parties have therefore agreed not to move forward with the transaction at this stage," the company said.

BIS Raids Warehouses of Flipkart & Amazon; Seizes 4,000+ Products

Our Bureau

New Delhi: The Bureau of Indian Standards (BIS), the national standards body, carried out a search and seizure operation last week at the warehouses of ecommerce giants Amazon and Flipkart in Delhi, and seized thousands of products that were in violation of quality control orders. During the inspection at Amazon's warehouses on March

19, over 3,500 products were seized. The products either did not have an ISI mark or had fake ISI marks. They included geysers, food mixers and other electrical appliances worth ₹70 lakh, the Ministry of Consumer Affairs, Food & Public Distribution, under which the BIS functions, said in a release.

In a separate operation, the standards body searched a Flipkart subsidiary, Instakart Services, finding a stock of sports footwear packaged for dispatch without the necessary ISI markings and date of manufacture. Over 590 pairs of sports shoes worth ₹6 lakh were seized.

राज्य सरकारकडून २.८१ कोटी मंजूर

महाराष्ट्र क्रीडा क्षेत्रात अग्रगण्य व्हावा, राज्यातील खेळाडूंनी राष्ट्रीय आणि आंतरराष्ट्रीय पातळीवर दर्जेदार कामगिरी करावी, त्यासाठी त्यांना आंतरराष्ट्रीय पातळीचे प्रशिक्षण मिळावे, या हेतूने राज्य सरकारने गेल्या दशकात क्रीडा धोरण तयार केले. या धोरणातील शिफारशीनुसार, खेळाडूंची गुणवत्ता हेरून त्यांना पेलू पाडण्यासाठी प्रत्येक जिल्ह्यात प्रशिक्षणाची सुविधा उपलब्ध करून देण्याचे निश्चित करण्यात आले.

आता राज्यातील ३३ जिल्ह्यांमधील प्रशिक्षण केंद्रांना दोन कोटी ८१ लाखांचा निधी वितरित होणार आहे. यात सर्वाधिक १३ लाख ३५ हजार रुपये सांगली जिल्ह्यातील केंद्रासाठी देण्यात आले असून, अमरावती, अकोला, अहिल्यानगर आणि नागपूर या जिल्ह्यांसाठी १२ लाखांपेक्षा जास्त निधीची तरतृद करण्यात आली आहे. आदिवासी जिल्हे म्हणून ओळख असलेल्या नंदुरबार आणि पालघर या जिल्ह्यांना चार लाखांपेक्षाही कमी निधी देण्यात आला आहे.
