# CIDCO Rakes in Over ₹100 cr by Leasing Out

## 4 Navi Mumbai Plots

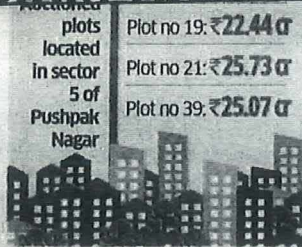
**Mumbai:** Defying the current property market scenario, the City and Industrial Development Corporation (CIDCO) has fetched over ₹100 crore in a day by leasing out four plots in Pushpak Nagar, a greenfield smart city to be developed in Navi Mumbai.

Interestingly, all the four plots — each measuring nearly an acre — have received more than the reserve price of ₹55.216 per square metre, or ₹22.34 crore. The plots had an FSI of two, and are allowed, commercial, residential, and even commercial plus residential use.

CIDCO, the planning authority for the Navi Mumbai region, confirmed generating revenue of ₹101 crore through the long-term lease of these plots to local developers.

The auctioned plots — 2, 19, 21 and 39 — are located in sector five of Pushpak Nagar and bids for the plots were invited through both the e-tender and e-auction processes.

While plot number 2 had the highest bid at ₹86,216 per sq metre, plot number 19 saw the



highest bid of ₹68,216 per sq metre. Plot number 21 witnessed the highest bid of ₹78,216 per sq metre and plot number 39 saw the highest bid of ₹76,221 per sq metre.

Each of these plots got bids from at least three bidders, except for plot number 21 for which there were a total of four bidders.

Plot number two got them revenue worth ₹28.36 crore, plot number 19 got CIDCO ₹22.44 crore, plot number 21, generated a revenue of ₹25.73 crore and the last plot number 39 generated ₹25.07 crore, thus taking the total revenue generated to ₹101 crore.

CIDCO has been putting up plots in various nodes of the town up for long lease where developers acquire them from CIDCO and then use the land to build residential or commercial projects.

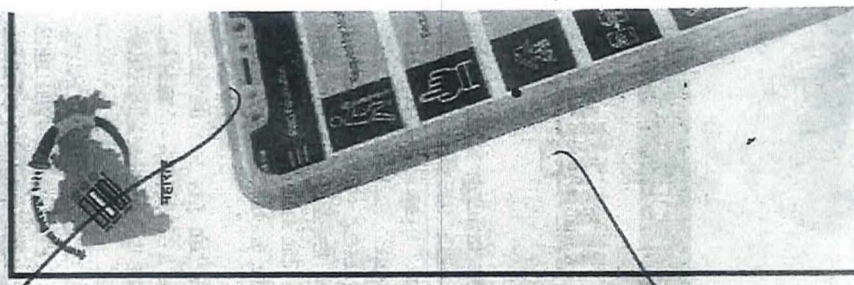
